YEARLY/LIFETIME COST OF TREATMENT FOR DEPRESSION/ANXIETY

Lifetime psychiatric treatment is necessary because many patients are refractory to current treatment and/or have a concomitant physical or neurologic injury.

APPROXIMATE COSTS FOR LIFETIME TREATMENT

1. Psychiatric Treatment

\$200.00 per session/50 sessions a year \$10,000.00

2. Medication

**For Depression: Zoloft, 50mg., 4/day
@ \$2.35 per tablet \$3,431.10**

**For Anxiety: Buspar, 10mg., 4/day
@ \$1.38 per tablet \$2,014.80**

**For Sleep: Remeron, 15mg., 2/night
@ \$2.42 per tablet \$1,766.60**

COST OF TREATMENT/MEDICATION FOR 10 YEARS \$170,212.50

COST OF TREATMENT/MEDICATION FOR 20 YEARS \$344,250.00
